IN ORDER TO FILE FOR ADMINISTRATION, THE COURT NEEDS THE FOLLOWING:

- 1) Petition for Letters of Administration
- * Bond (For more information, see below.)
- 3) Certified copy of Death Certificate
- **4) \$111.00 Filing Fee** (We accept cash, money order, or credit/debit cards)

(The filing fee includes \$45.00 for Court Cost and \$66.00 for Notice to Creditors)

REQUIREMENTS:

- 1) PETITIONER MUST BE AN ALABAMA RESIDENT
- 2) PERSONAL ESTATE MUST BE ITEMIZED SEE FOLLOWING EXAMPLE: Regions Bank \$0.00, 1940 Chevrolet Silverado \$0.00, furniture \$0.00, Jewelry \$0.00.
- 3) **BOND** CONTACT INSURANCE COMPANY AND THEY WILL ISSUE THE BOND. * (Note: A minimum bond of \$10,000 is required.)
 - 1. The names of the deceased and the administrator on the bond must agree with the names on the petition for letters of administration.
 - 2. Amount of bond is the **Total of Rental Income and Personal Estate** figured as follows:
 - One year's estimated rental income on real property
 - One year's estimated income from investments (stocks, bonds)
 - Total value of personal property (vehicles, cash/investments, household items, stocks/bonds, etc.)
 - <u>Important:</u> Do not include property <u>in the bond amount</u> (such as real estate) that cannot be disposed of without court order or securities deposited under arrangements requiring an order of the court.
